UNDERSTANDING BEAVER COUNTY PROPERTY TAX ASSESSMENT

THE BEAVER COUNTY PROPERTY TAX ASSESSMENT IS THE OFFICIAL EVALUATION OF REAL ESTATE PROPERTIES CONDUCTED TO ESTABLISH THEIR FAIR MARKET VALUE FOR TAXATION PURPOSES. THIS PROCESS IS CARRIED OUT BY THE BEAVER COUNTY ASSESSMENT OFFICE, WHICH ENSURES THAT PROPERTY VALUES ARE EQUITABLE AND CONSISTENT ACROSS THE COUNTY. THE ASSESSED VALUE FORMS THE BASIS UPON WHICH PROPERTY TAXES ARE CALCULATED, MAKING IT A PIVOTAL ELEMENT IN LOCAL GOVERNMENT REVENUE GENERATION. PROPERTY TAXES FUND ESSENTIAL PUBLIC SERVICES SUCH AS SCHOOLS, INFRASTRUCTURE, EMERGENCY SERVICES, AND COMMUNITY DEVELOPMENT PROJECTS WITHIN BEAVER COUNTY.

ASSESSMENT PROCESS AND TIMELINE

KEY DATES AND DEADLINES

IT IS IMPORTANT FOR PROPERTY OWNERS TO BE AWARE OF CRITICAL DEADLINES RELATED TO THE ASSESSMENT PROCESS, INCLUDING THE DATE BY WHICH APPEALS MUST BE FILED. MISSING THESE DEADLINES CAN FORFEIT THE OPPORTUNITY TO CHALLENGE AN ASSESSMENT.

FACTORS AFFECTING PROPERTY VALUATION

PROPERTY SIZE AND IMPROVEMENTS

THE TOTAL SQUARE FOOTAGE, LOT SIZE, AND ANY STRUCTURAL IMPROVEMENTS OR ADDITIONS (SUCH AS GARAGES, POOLS, OR RENOVATIONS) CONTRIBUTE TO THE OVERALL ASSESSED VALUE.

MARKET CONDITIONS AND COMPARABLE SALES

CURRENT REAL ESTATE MARKET TRENDS AND RECENT SALES OF COMPARABLE PROPERTIES IN THE AREA ARE ANALYZED TO ENSURE THE ASSESSMENT REFLECTS TRUE MARKET VALUE.

PROPERTY CONDITION AND AGE

THE PHYSICAL CONDITION AND AGE OF THE PROPERTY ARE EVALUATED, WITH NEWER OR WELL-MAINTAINED PROPERTIES GENERALLY COMMANDING HIGHER ASSESSED VALUES.

USE AND ZONING RESTRICTIONS

ZONING LAWS AND THE PERMITTED USE OF THE PROPERTY CAN AFFECT ITS VALUATION, PARTICULARLY FOR COMMERCIAL OR INDUSTRIAL PROPERTIES.

HOW PROPERTY TAXES ARE CALCULATED IN BEAVER COUNTY

THE CALCULATION OF PROPERTY TAXES IN BEAVER COUNTY IS BASED ON THE ASSESSED VALUE DETERMINED DURING THE PROPERTY TAX ASSESSMENT, COMBINED WITH THE APPLICABLE TAX RATES SET BY LOCAL TAXING AUTHORITIES.

ASSESSED VALUE VERSUS MARKET VALUE

THE ASSESSED VALUE IS TYPICALLY A PERCENTAGE OF THE MARKET VALUE, AS DETERMINED BY THE ASSESSMENT OFFICE. THIS VALUE REPRESENTS THE TAXABLE AMOUNT OF THE PROPERTY.

MILLAGE RATES AND TAXING AUTHORITIES

PROPERTY TAX RATES, OFTEN EXPRESSED IN MILLS (ONE MILL EQUALS ONE-TENTH OF A CENT), ARE SET BY VARIOUS ENTITIES SUCH AS THE COUNTY, SCHOOL DISTRICTS, MUNICIPALITIES, AND SPECIAL DISTRICTS. THE AGGREGATE MILLAGE RATE IS APPLIED TO THE ASSESSED VALUE TO CALCULATE THE TOTAL TAX DUE.

EXAMPLE CALCULATION

FOR EXAMPLE, IF A PROPERTY IS ASSESSED AT \$150,000 AND THE COMBINED MILLAGE RATE IS 25 MILLS (0.025), THE ANNUAL PROPERTY TAX WOULD BE:

- $\text{TAX} = \text{ASSESSED VALUE} \times \text{MILLAGE RATE}$
- $\text{TAX} = \$150,000 \times 0.025 = \$3,750$

APPEALING YOUR PROPERTY TAX ASSESSMENT

PROPERTY OWNERS WHO BELIEVE THEIR BEAVER COUNTY PROPERTY TAX ASSESSMENT IS INACCURATE OR UNFAIR HAVE THE RIGHT TO APPEAL THE ASSESSMENT THROUGH A FORMAL PROCESS. THIS ENSURES TAXPAYERS ARE NOT OVERBURDENED BY EXCESSIVE TAX LIABILITIES.

GROUND FOR APPEAL

COMMON REASONS FOR APPEALING AN ASSESSMENT INCLUDE:

- ERRORS IN PROPERTY DATA OR DESCRIPTION

- INCORRECT PROPERTY SIZE OR CONDITION DETAILS
- MARKET VALUE DISCREPANCIES COMPARED TO SIMILAR PROPERTIES
- ASSESSMENT INEQUITIES AMONG COMPARABLE PROPERTIES

FILING AN APPEAL

TO INITIATE AN APPEAL, PROPERTY OWNERS MUST SUBMIT A WRITTEN REQUEST TO THE BEAVER COUNTY BOARD OF ASSESSMENT APPEALS WITHIN THE SPECIFIED TIMEFRAME AFTER RECEIVING THEIR ASSESSMENT NOTICE. SUPPORTING DOCUMENTATION SUCH AS RECENT APPRAISALS, SALES DATA, OR REPAIR ESTIMATES SHOULD BE INCLUDED.

APPEAL HEARING PROCESS

THE BOARD OF ASSESSMENT APPEALS REVIEWS THE EVIDENCE AND MAY HOLD A HEARING WHERE PROPERTY OWNERS CAN PRESENT THEIR CASE. BASED ON THE FINDINGS, THE BOARD MAY ADJUST THE ASSESSED VALUE ACCORDINGLY.
