DEFINITION AND SCOPE OF CRQ

TYPES OF CHANGE REQUESTS

CRQ PROCESS LIFECYCLE

APPROVAL OR REJECTION

BASED ON THE ANALYSIS, THE AUTHORIZED CHANGE CONTROL BOARD (CCB) OR PROJECT GOVERNANCE BODY DECIDES WHETHER TO APPROVE, REJECT, OR REQUEST MODIFICATIONS TO THE CRQ. THIS DECISION-MAKING STEP IS ESSENTIAL TO MAINTAIN PROJECT INTEGRITY AND STAKEHOLDER CONSENSUS.

IMPLEMENTATION AND MONITORING

APPROVED CRQS ARE IMPLEMENTED ACCORDING TO A DEFINED PLAN, WITH UPDATES MADE TO PROJECT DOCUMENTS AND SCHEDULES. CONTINUOUS MONITORING ENSURES THAT CHANGES ARE EXECUTED CORRECTLY AND ANY EMERGING ISSUES ARE ADDRESSED PROMPTLY.

CLOSURE AND DOCUMENTATION

AFTER IMPLEMENTATION, THE CRQ IS FORMALLY CLOSED WITH DOCUMENTATION REFLECTING THE OUTCOMES AND LESSONS LEARNED. THIS CLOSURE REINFORCES ACCOUNTABILITY AND PROVIDES HISTORICAL DATA FOR FUTURE PROJECTS.
