OVERVIEW OF THE CSUDH FINANCIAL AID OFFICE

THE CSUDH FINANCIAL AID OFFICE SERVES AS THE CENTRAL HUB FOR ALL FINANCIAL ASSISTANCE PROGRAMS AT CALIFORNIA STATE UNIVERSITY, DOMINGUEZ HILLS. ITS MISSION IS TO PROVIDE EQUITABLE ACCESS TO FINANCIAL RESOURCES THAT HELP STUDENTS ACHIEVE ACADEMIC SUCCESS. THE OFFICE OFFERS COMPREHENSIVE SUPPORT, INCLUDING COUNSELING, APPLICATION ASSISTANCE, AND INFORMATION DISSEMINATION ABOUT AVAILABLE AID PROGRAMS. STAFF MEMBERS ARE TRAINED TO GUIDE STUDENTS THROUGH FEDERAL, STATE, AND INSTITUTIONAL FINANCIAL AID OPTIONS, ENSURING THAT STUDENTS UNDERSTAND THEIR RESPONSIBILITIES AND BENEFITS.

LOCATION AND CONTACT INFORMATION

THE FINANCIAL AID OFFICE IS CONVENIENTLY LOCATED ON THE CSUDH CAMPUS, EASILY ACCESSIBLE TO STUDENTS. IT OPERATES DURING REGULAR BUSINESS HOURS AND PROVIDES MULTIPLE CHANNELS FOR COMMUNICATION, INCLUDING PHONE, EMAIL, AND IN-PERSON APPOINTMENTS. THIS ACCESSIBILITY ENSURES STUDENTS CAN RECEIVE TIMELY ASSISTANCE AND UPDATES REGARDING THEIR FINANCIAL AID STATUS.

MISSION AND SERVICES

THE PRIMARY MISSION OF THE CSUDH FINANCIAL AID OFFICE IS TO PROMOTE STUDENT RETENTION AND SUCCESS BY REDUCING FINANCIAL BARRIERS TO EDUCATION. SERVICES INCLUDE FINANCIAL COUNSELING, FAFSA ASSISTANCE, SCHOLARSHIP GUIDANCE, AND DISBURSEMENT OF FUNDS. THE OFFICE ALSO OFFERS WORKSHOPS AND INFORMATIONAL SESSIONS TO HELP STUDENTS UNDERSTAND FINANCIAL LITERACY AND MANAGE THEIR EDUCATIONAL EXPENSES EFFECTIVELY.

TYPES OF FINANCIAL AID AVAILABLE

THE CSUDH FINANCIAL AID OFFICE ADMINISTERS A VARIETY OF FINANCIAL AID PROGRAMS DESIGNED TO MEET DIVERSE STUDENT

NEEDS. AID IS CATEGORIZED INTO GRANTS, SCHOLARSHIPS, LOANS, AND WORK-STUDY OPPORTUNITIES. UNDERSTANDING THESE OPTIONS IS CRITICAL TO MAXIMIZING THE BENEFITS OFFERED BY THE UNIVERSITY AND EXTERNAL AGENCIES.

GRANTS

GRANTS ARE NEED-BASED FINANCIAL AWARDS THAT DO NOT REQUIRE REPAYMENT. THE OFFICE HELPS STUDENTS ACCESS FEDERAL GRANTS SUCH AS THE PELL GRANT, STATE GRANTS LIKE THE CAL GRANT, AND INSTITUTIONAL GRANTS OFFERED BY CSUDH. THESE GRANTS ARE TYPICALLY AWARDED BASED ON DEMONSTRATED FINANCIAL NEED AND OTHER ELIGIBILITY FACTORS.

SCHOLARSHIPS

SCHOLARSHIPS AWARDED THROUGH THE CSUDH FINANCIAL AID OFFICE RECOGNIZE ACADEMIC ACHIEVEMENT, LEADERSHIP, COMMUNITY INVOLVEMENT, AND SPECIFIC FIELDS OF STUDY. THESE MERIT-BASED AWARDS PROVIDE STUDENTS WITH ADDITIONAL FUNDS THAT DO NOT NEED TO BE repaid. THE OFFICE MAINTAINS A SCHOLARSHIP DATABASE AND ADVISES STUDENTS ON APPLICATION PROCEDURES AND DEADLINES.

LOANS

STUDENT LOANS ARE AVAILABLE FOR THOSE WHO REQUIRE ADDITIONAL FINANCIAL ASSISTANCE. THE CSUDH FINANCIAL AID OFFICE FACILITATES FEDERAL STUDENT LOANS SUCH AS DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS, AS WELL AS PARENT PLUS LOANS. WHILE LOANS MUST BE repaid WITH INTEREST, THEY OFFER FLEXIBLE REPAYMENT PLANS AND DEFERRED PAYMENT OPTIONS DURING SCHOOL ENROLLMENT.

WORK-STUDY PROGRAMS

WORK-STUDY IS A FEDERALLY FUNDED PROGRAM THAT PROVIDES PART-TIME EMPLOYMENT TO ELIGIBLE STUDENTS, ALLOWING THEM TO EARN MONEY TO HELP PAY FOR EDUCATION EXPENSES. THE FINANCIAL AID OFFICE COORDINATES WORK-STUDY PLACEMENTS ON AND OFF CAMPUS, ENCOURAGING STUDENTS TO GAIN VALUABLE WORK EXPERIENCE ALONGSIDE THEIR STUDIES.

APPLICATION PROCESS AND ELIGIBILITY REQUIREMENTS

THE PROCESS TO SECURE FINANCIAL AID THROUGH THE CSUDH FINANCIAL AID OFFICE INVOLVES SEVERAL KEY STEPS, BEGINNING WITH COMPLETING THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) OR THE CALIFORNIA DREAM ACT APPLICATION FOR ELIGIBLE NON-CITIZENS. THE OFFICE PROVIDES DETAILED GUIDANCE TO ENSURE APPLICATIONS ARE COMPLETED ACCURATELY AND SUBMITTED ON TIME.

FAFSA AND CALIFORNIA DREAM ACT APPLICATION

FILING THE FAFSA IS THE PRIMARY STEP FOR STUDENTS SEEKING FEDERAL AND STATE AID. THE CSUDH FINANCIAL AID OFFICE ENCOURAGES EARLY SUBMISSION TO MAXIMIZE FUNDING OPPORTUNITIES. FOR UNDOCUMENTED STUDENTS OR THOSE WITHOUT A SOCIAL SECURITY NUMBER, THE CALIFORNIA DREAM ACT APPLICATION IS THE ALTERNATIVE TO ACCESS STATE AND INSTITUTIONAL AID.

ELIGIBILITY CRITERIA

TO QUALIFY FOR FINANCIAL AID, STUDENTS MUST MEET SEVERAL ELIGIBILITY REQUIREMENTS. THESE GENERALLY INCLUDE ENROLLMENT IN AN ELIGIBLE PROGRAM, MAINTAINING SATISFACTORY ACADEMIC PROGRESS, AND MEETING CITIZENSHIP OR RESIDENCY STANDARDS. THE CSUDH FINANCIAL AID OFFICE EVALUATES EACH STUDENT'S APPLICATION AND DOCUMENTATION TO

DETERMINE AID ELIGIBILITY.

VERIFICATION AND DOCUMENTATION

SELECTED APPLICANTS MAY BE REQUIRED TO SUBMIT ADDITIONAL DOCUMENTATION FOR VERIFICATION PURPOSES. THE OFFICE PROVIDES CLEAR INSTRUCTIONS ON REQUIRED DOCUMENTS SUCH AS TAX RETURNS, INCOME STATEMENTS, AND RESIDENCY PROOFS. PROMPT RESPONSE TO VERIFICATION REQUESTS IS ESSENTIAL TO AVOID DELAYS IN AID DISBURSEMENT.

IMPORTANT DEADLINES AND TIMELINE

TIMELINESS IS CRUCIAL WHEN APPLYING FOR FINANCIAL AID THROUGH THE CSUDH FINANCIAL AID OFFICE. MISSING DEADLINES CAN RESULT IN REDUCED AID ELIGIBILITY OR LOSS OF CERTAIN FUNDING OPPORTUNITIES. THIS SECTION OUTLINES KEY DATES AND THE TYPICAL TIMELINE STUDENTS SHOULD FOLLOW.

FAFSA AND CALIFORNIA DREAM ACT DEADLINES

STUDENTS ARE ADVISED TO SUBMIT THEIR FAFSA OR CALIFORNIA DREAM ACT APPLICATION AS SOON AS POSSIBLE AFTER OCTOBER 1 FOR THE UPCOMING ACADEMIC YEAR. EARLY APPLICATION INCREASES THE CHANCES OF RECEIVING LIMITED FUNDS SUCH AS CAL GRANTS AND INSTITUTIONAL SCHOLARSHIPS. THE CSUDH FINANCIAL AID OFFICE PUBLISHES SPECIFIC DEADLINE DATES ANNUALLY TO GUIDE STUDENTS.

CSUDH FINANCIAL AID OFFICE DEADLINES

BEYOND FEDERAL AND STATE DEADLINES, THE CSUDH FINANCIAL AID OFFICE SETS INTERNAL DEADLINES FOR SCHOLARSHIP APPLICATIONS, LOAN COUNSELING, AND WORK-STUDY PROGRAM PARTICIPATION. ADHERING TO THESE TIMELINES ENSURES STUDENTS REMAIN ELIGIBLE FOR ALL APPLICABLE AID PROGRAMS AND RECEIVE FUNDS IN A TIMELY MANNER.

ADDITIONAL RESOURCES AND SUPPORT SERVICES

IN ADDITION TO PROCESSING FINANCIAL AID APPLICATIONS, THE CSUDH FINANCIAL AID OFFICE OFFERS A RANGE OF RESOURCES TO SUPPORT STUDENTS' FINANCIAL WELL-BEING AND ACADEMIC SUCCESS. THESE SERVICES HELP STUDENTS MANAGE THEIR FINANCES AND NAVIGATE CHALLENGES DURING THEIR COLLEGE JOURNEY.

FINANCIAL LITERACY WORKSHOPS

WORKSHOPS ON BUDGETING, DEBT MANAGEMENT, AND RESPONSIBLE BORROWING ARE REGULARLY CONDUCTED BY THE FINANCIAL AID OFFICE. THESE SESSIONS EQUIP STUDENTS WITH SKILLS TO MAKE INFORMED FINANCIAL DECISIONS AND REDUCE THE RISK OF EXCESSIVE DEBT ACCUMULATION.

EMERGENCY AID PROGRAMS

THE CSUDH FINANCIAL AID OFFICE COORDINATES EMERGENCY GRANT PROGRAMS TO ASSIST STUDENTS FACING UNEXPECTED FINANCIAL HARDSHIPS. THESE SHORT-TERM FUNDS HELP STUDENTS COVER URGENT EXPENSES SUCH AS HOUSING, FOOD, AND MEDICAL BILLS, ENABLING THEM TO CONTINUE THEIR EDUCATION WITHOUT INTERRUPTION.

ADVISING AND COUNSELING SERVICES

PERSONALIZED ADVISING IS AVAILABLE TO HELP STUDENTS UNDERSTAND THEIR FINANCIAL AID PACKAGES, REPAYMENT OPTIONS, AND ELIGIBILITY FOR ADDITIONAL FUNDS. THE OFFICE ENCOURAGES STUDENTS TO SCHEDULE CONSULTATIONS FOR TAILORED FINANCIAL PLANNING AND TO RESOLVE ANY AID-RELATED CONCERNS.

ONLINE RESOURCES AND TOOLS

THE CSUDH FINANCIAL AID OFFICE PROVIDES ONLINE PORTALS AND RESOURCES THAT ALLOW STUDENTS TO CHECK THEIR FINANCIAL AID STATUS, SUBMIT REQUIRED DOCUMENTS, AND ESTIMATE THEIR FINANCIAL AID ELIGIBILITY. THESE TOOLS STREAMLINE COMMUNICATION AND PROVIDE TRANSPARENCY THROUGHOUT THE AID PROCESS.

HOW DO I CHECK THE STATUS OF MY FINANCIAL AID APPLICATION AT CSUDH?

YOU CAN CHECK THE STATUS OF YOUR FINANCIAL AID APPLICATION BY LOGGING INTO YOUR MYCSUDH STUDENT PORTAL AND NAVIGATING TO THE FINANCIAL AID SECTION FOR UPDATES AND NOTIFICATIONS.
