UNDERSTANDING CULVER CITY BUSINESS LICENSES

A BUSINESS LICENSE IN CULVER CITY IS A PERMIT ISSUED BY THE LOCAL GOVERNMENT THAT GRANTS PERMISSION TO OPERATE A COMMERCIAL ENTERPRISE WITHIN CITY LIMITS.
