FORENSIC HEALTH MINOR BINGHAMTON OFFERS STUDENTS A UNIQUE INTERDISCIPLINARY OPPORTUNITY TO EXPLORE THE INTERSECTION OF HEALTH SCIENCES, CRIMINAL JUSTICE, AND FORENSIC INVESTIGATION. THIS MINOR IS DESIGNED TO COMPLEMENT VARIOUS MAJORS BY PROVIDING SPECIALIZED KNOWLEDGE IN FORENSIC HEALTH, PREPARING STUDENTS FOR CAREERS IN FORENSIC SCIENCE, PUBLIC HEALTH, LAW ENFORCEMENT, AND RELATED FIELDS. BINGHAMTON UNIVERSITY'S FORENSIC HEALTH MINOR COMBINES COURSEWORK IN BIOLOGY, CHEMISTRY, CRIMINAL JUSTICE, AND HEALTH SCIENCES TO EQUIP STUDENTS WITH THE SKILLS NECESSARY TO ANALYZE EVIDENCE, UNDERSTAND LEGAL PROCESSES, AND PROMOTE HEALTH AND SAFETY WITHIN FORENSIC CONTEXTS. OVERVIEW OF THE FORENSIC HEALTH MINOR AT BINGHAMTON

THE FORENSIC HEALTH MINOR AT BINGHAMTON UNIVERSITY IS AN INTERDISCIPLINARY PROGRAM DESIGNED TO PROVIDE STUDENTS WITH FOUNDATIONAL KNOWLEDGE IN FORENSIC SCIENCE AND HEALTH-RELATED FIELDS. IT INTEGRATES PRINCIPLES FROM BIOLOGY, CHEMISTRY, CRIMINAL JUSTICE, AND PUBLIC HEALTH TO PREPARE STUDENTS FOR ROLES THAT INVOLVE ANALYZING PHYSICAL EVIDENCE, UNDERSTANDING FORENSIC PATHOLOGY, AND ADDRESSING HEALTH CONCERNS WITHIN LEGAL FRAMEWORKS. THIS MINOR IS ESPECIALLY SUITED FOR STUDENTS MAJORING IN HEALTH SCIENCES, BIOLOGY, PSYCHOLOGY, OR CRIMINAL JUSTICE WHO SEEK TO EXPAND THEIR EXPERTISE IN FORENSIC APPLICATIONS.

PURPOSE AND OBJECTIVES

THE PRIMARY OBJECTIVE OF THE FORENSIC HEALTH MINOR IS TO EQUIP STUDENTS WITH THE SCIENTIFIC AND ANALYTICAL SKILLS NECESSARY TO CONTRIBUTE EFFECTIVELY TO FORENSIC INVESTIGATIONS AND PUBLIC HEALTH INITIATIVES. THE PROGRAM AIMS TO FOSTER AN UNDERSTANDING OF HOW FORENSIC SCIENCE INTERSECTS WITH HEALTH AND LEGAL SYSTEMS, ENABLING GRADUATES TO SUPPORT CRIMINAL INVESTIGATIONS, POLICY DEVELOPMENT, AND COMMUNITY HEALTH PROGRAMS.

INTERDISCIPLINARY APPROACH

BINGHAMTON'S FORENSIC HEALTH MINOR EMPHASIZES AN INTERDISCIPLINARY CURRICULUM THAT COMBINES COURSEWORK FROM MULTIPLE DEPARTMENTS. THIS APPROACH ENSURES STUDENTS GAIN A WELL-ROUNDED PERSPECTIVE ON FORENSIC HEALTH, INCLUDING LABORATORY TECHNIQUES, LEGAL CONSIDERATIONS, AND HEALTH IMPLICATIONS. THE MINOR PROMOTES CRITICAL THINKING AND PROBLEM-SOLVING SKILLS BY ENGAGING STUDENTS IN CASE STUDIES, LABORATORY EXERCISES, AND APPLIED RESEARCH.

CURRICULUM AND COURSE REQUIREMENTS

THE FORENSIC HEALTH MINOR AT BINGHAMTON UNIVERSITY REQUIRES COMPLETION OF A SERIES OF COURSES DESIGNED TO PROVIDE BOTH THEORETICAL KNOWLEDGE AND PRACTICAL EXPERIENCE. THE CURRICULUM INCLUDES CORE COURSES IN FORENSIC SCIENCE FUNDAMENTALS, HEALTH SCIENCES, AND CRIMINAL JUSTICE, ALONG WITH ELECTIVES THAT ALLOW STUDENTS TO TAILOR THEIR STUDIES TO SPECIFIC INTERESTS.

CORE COURSES

STUDENTS PURSUING THE FORENSIC HEALTH MINOR MUST COMPLETE FOUNDATIONAL COURSES THAT COVER ESSENTIAL TOPICS IN FORENSIC SCIENCE AND HEALTH. TYPICAL CORE COURSES INCLUDE:

- INTRODUCTION TO FORENSIC SCIENCE – COVERING THE BASICS OF EVIDENCE COLLECTION, ANALYSIS, AND INTERPRETATION.
- HUMAN ANATOMY AND PHYSIOLOGY – PROVIDING A BIOLOGICAL FRAMEWORK RELEVANT TO FORENSIC INVESTIGATIONS.
- CRIMINAL JUSTICE SYSTEMS – OFFERING INSIGHT INTO LEGAL PROCEDURES AND THE ROLE OF FORENSIC EVIDENCE IN COURTS.
- HEALTH AND DISEASE IN SOCIETY – EXPLORING PUBLIC HEALTH CONCEPTS AND THEIR FORENSIC APPLICATIONS.

ELECTIVE OPTIONS

TO ENHANCE THEIR LEARNING, STUDENTS CAN SELECT ELECTIVE COURSES FROM RELATED DISCIPLINES SUCH AS TOXICOLOGY, FORENSIC PSYCHOLOGY, PATHOLOGY, OR ENVIRONMENTAL HEALTH. THESE ELECTIVES ALLOW FOR SPECIALIZATION AND DEEPER UNDERSTANDING OF NICHE AREAS WITHIN FORENSIC HEALTH.

PRACTICAL EXPERIENCE AND LAB WORK

HANDS-ON EXPERIENCE IS A CRITICAL COMPONENT OF THE FORENSIC HEALTH MINOR. MANY COURSES INCLUDE LABORATORY SESSIONS WHERE STUDENTS PRACTICE EVIDENCE ANALYSIS, TOXICOLOGY TESTING, AND FORENSIC TECHNIQUES. SOME STUDENTS MAY ALSO HAVE OPPORTUNITIES TO ENGAGE IN INTERNSHIPS OR RESEARCH PROJECTS THAT PROVIDE REAL-WORLD APPLICATION OF THEIR KNOWLEDGE.

SKILLS AND COMPETENCIES DEVELOPED

THE FORENSIC HEALTH MINOR AT BINGHAMTON CULTIVATES A DIVERSE SKILL SET ESSENTIAL FOR FORENSIC AND HEALTH-RELATED PROFESSIONS. STUDENTS DEVELOP ANALYTICAL, TECHNICAL, AND COMMUNICATION SKILLS THAT ENABLE THEM TO NAVIGATE COMPLEX FORENSIC SCENARIOS EFFECTIVELY.

ANALYTICAL AND TECHNICAL SKILLS

STUDENTS LEARN TO COLLECT, ANALYZE, AND INTERPRET FORENSIC EVIDENCE USING SCIENTIFIC METHODS. THEY GAIN PROFICIENCY IN LABORATORY TECHNIQUES SUCH AS MICROSCOPY, CHEMICAL ANALYSIS, AND BIOLOGICAL ASSAYS RELEVANT TO FORENSIC INVESTIGATIONS.

UNDERSTANDING OF LEGAL AND ETHICAL ISSUES

KNOWLEDGE OF THE CRIMINAL JUSTICE SYSTEM AND ETHICAL CONSIDERATIONS IS INTEGRAL TO THE MINOR. STUDENTS STUDY LEGAL STANDARDS FOR EVIDENCE ADMISSIBILITY, CONFIDENTIALITY REQUIREMENTS, AND ETHICAL DILEMMAS ENCOUNTERED IN FORENSIC HEALTH PRACTICE.

COMMUNICATION AND REPORTING

EFFECTIVE COMMUNICATION IS CRITICAL IN FORENSIC HEALTH FIELDS. THE MINOR EMPHASIZES CLEAR AND ACCURATE REPORTING OF FINDINGS, BOTH IN WRITTEN AND VERBAL FORMATS, TO ENSURE THAT EVIDENCE CAN BE PROPERLY PRESENTED IN LEGAL OR PUBLIC HEALTH CONTEXTS.

CAREER OPPORTUNITIES AND PROFESSIONAL APPLICATIONS

THE FORENSIC HEALTH MINOR AT BINGHAMTON OPENS PATHWAYS TO VARIOUS CAREERS IN FORENSIC SCIENCE, PUBLIC HEALTH, LAW ENFORCEMENT, AND RELATED SECTORS. THE INTERDISCIPLINARY TRAINING PREPARES GRADUATES FOR ROLES THAT REQUIRE BOTH SCIENTIFIC EXPERTISE AND AN UNDERSTANDING OF HEALTH AND LEGAL SYSTEMS.

POTENTIAL CAREER PATHS

- FORENSIC SCIENCE TECHNICIAN – ASSISTING IN CRIME SCENE INVESTIGATION AND LABORATORY ANALYSIS.
- PUBLIC HEALTH ANALYST – EVALUATING HEALTH DATA RELATED TO LEGAL OR FORENSIC ISSUES.
- CRIME LABORATORY ANALYST – SPECIALIZING IN BIOLOGICAL OR CHEMICAL EVIDENCE EXAMINATION.
- LAW ENFORCEMENT SUPPORT SPECIALIST – PROVIDING EXPERTISE IN HEALTH-RELATED FORENSIC MATTERS.
- FORENSIC PATHOLOGY ASSISTANT – SUPPORTING MEDICAL EXAMINERS IN AUTOPSY AND PATHOLOGY SERVICES.

GRADUATE AND PROFESSIONAL STUDIES

THE MINOR ALSO SERVES AS A STRONG FOUNDATION FOR ADVANCED STUDIES IN FORENSIC SCIENCE, MEDICINE, LAW, OR PUBLIC HEALTH. STUDENTS MAY PURSUE GRADUATE DEGREES OR PROFESSIONAL CERTIFICATIONS TO FURTHER SPECIALIZE AND ENHANCE THEIR CAREER PROSPECTS.

ADMISSION CRITERIA AND ENROLLMENT PROCESS

ADMISSION TO THE FORENSIC HEALTH MINOR AT BINGHAMTON UNIVERSITY TYPICALLY REQUIRES STUDENTS TO BE ENROLLED IN AN UNDERGRADUATE DEGREE PROGRAM AT THE UNIVERSITY. THE MINOR IS AVAILABLE TO STUDENTS FROM VARIOUS MAJORS, WITH SOME PREREQUISITES RECOMMENDED TO ENSURE READINESS FOR ADVANCED COURSEWORK.

PREREQUISITES AND ELIGIBILITY

STUDENTS INTERESTED IN THE FORENSIC HEALTH MINOR SHOULD HAVE COMPLETED INTRODUCTORY COURSES IN BIOLOGY AND CHEMISTRY. SOME PROGRAMS MAY REQUIRE A MINIMUM GPA OR INSTRUCTOR APPROVAL FOR ENROLLMENT IN ADVANCED COURSES.

APPLICATION AND DECLARATION

TO DECLARE THE FORENSIC HEALTH MINOR, STUDENTS USUALLY NEED TO SUBMIT A FORMAL APPLICATION OR DECLARATION FORM THROUGH THEIR ACADEMIC ADVISOR OR THE PROGRAM COORDINATOR. EARLY CONSULTATION IS ENCOURAGED TO ENSURE PROPER COURSE PLANNING.

RESOURCES AND SUPPORT FOR FORENSIC HEALTH STUDENTS
