

# FORT MILL BUSINESS LICENSE

## UNDERSTANDING FORT MILL BUSINESS LICENSE

A FORT MILL BUSINESS LICENSE IS AN OFFICIAL PERMIT ISSUED BY THE TOWN OF FORT MILL THAT AUTHORIZES INDIVIDUALS OR ENTITIES TO CONDUCT BUSINESS ACTIVITIES WITHIN THE MUNICIPALITY. THIS LICENSE SERVES AS A REGULATORY MECHANISM TO ENSURE BUSINESSES OPERATE ACCORDING TO LOCAL LAWS, ZONING REGULATIONS, AND SAFETY STANDARDS. THE LICENSING PROCESS HELPS THE TOWN MONITOR ECONOMIC ACTIVITY, COLLECT APPROPRIATE TAXES, AND SAFEGUARD PUBLIC INTERESTS.

IN FORT MILL, NEARLY ALL BUSINESSES, INCLUDING RETAIL STORES, PROFESSIONAL SERVICES, RESTAURANTS, AND HOME-BASED OPERATIONS, MUST OBTAIN A BUSINESS LICENSE BEFORE COMMENCING OPERATIONS. THE LICENSE MUST BE DISPLAYED PROMINENTLY AT THE BUSINESS LOCATION TO DEMONSTRATE COMPLIANCE.

## ELIGIBILITY AND REQUIREMENTS

QUALIFYING FOR A FORT MILL BUSINESS LICENSE DEPENDS ON SEVERAL FACTORS INCLUDING THE TYPE OF BUSINESS, BUSINESS LOCATION, AND OWNERSHIP STRUCTURE. GENERALLY, ANY BUSINESS ENTITY—SOLE PROPRIETORSHIP, PARTNERSHIP, CORPORATION, OR LLC—OPERATING WITHIN FORT MILL'S CITY LIMITS NEEDS TO SECURE THIS LICENSE.

## BASIC ELIGIBILITY CRITERIA

APPLICANTS MUST MEET THE FOLLOWING CONDITIONS TO BE ELIGIBLE FOR A FORT MILL BUSINESS LICENSE:

- HAVE A VALID PHYSICAL ADDRESS FOR THE BUSINESS WITHIN FORT MILL OR ITS JURISDICTION.
- COMPLY WITH ZONING AND LAND USE REGULATIONS APPLICABLE TO THE BUSINESS LOCATION.

- PROVIDE PROOF OF REGISTRATION WITH THE SOUTH CAROLINA SECRETARY OF STATE, IF APPLICABLE.
- OBTAIN OTHER RELEVANT PERMITS OR CERTIFICATIONS, SUCH AS HEALTH DEPARTMENT PERMITS FOR FOOD SERVICE BUSINESSES OR PROFESSIONAL LICENSES FOR CERTAIN TRADES.
- SUBMIT A COMPLETED APPLICATION FORM ALONG WITH REQUIRED DOCUMENTATION.

## APPLICATION PROCESS FOR FORT MILL BUSINESS LICENSE

THE APPLICATION PROCESS FOR A FORT MILL BUSINESS LICENSE IS DESIGNED TO BE STRAIGHTFORWARD, ENSURING THAT BUSINESSES CAN BEGIN OPERATIONS WITHOUT UNNECESSARY DELAYS. THE TOWN'S BUSINESS LICENSING OFFICE MANAGES THE APPLICATION AND APPROVAL PROCESS.

### STEPS TO APPLY

TO APPLY FOR A FORT MILL BUSINESS LICENSE, FOLLOW THESE KEY STEPS:

1. COMPLETE THE OFFICIAL BUSINESS LICENSE APPLICATION FORM, AVAILABLE AT THE FORT MILL TOWN HALL OR ONLINE THROUGH THE TOWN'S WEBSITE.

3. SUBMIT THE APPLICATION ALONG WITH THE APPLICABLE FEES TO THE TOWN OF FORT MILL BUSINESS LICENSE DIVISION.
4. WAIT FOR APPLICATION REVIEW, WHICH MAY INCLUDE INSPECTIONS OR CONSULTATIONS TO ENSURE COMPLIANCE WITH LOCAL CODES.
5. RECEIVE THE APPROVED BUSINESS LICENSE, WHICH MUST BE DISPLAYED AT THE BUSINESS PREMISES.

## FEES AND PAYMENT DETAILS

FEES ASSOCIATED WITH OBTAINING A FORT MILL BUSINESS LICENSE VARY BASED ON THE NATURE AND SIZE OF THE BUSINESS. THE TOWN USES A STRUCTURED FEE SCHEDULE TO DETERMINE THE APPROPRIATE COST FOR EACH APPLICANT.

### FEE COMPONENTS

COMMON ELEMENTS THAT AFFECT LICENSE FEES INCLUDE:

- TYPE OF BUSINESS ACTIVITY
- GROSS RECEIPTS OR PROJECTED REVENUE
- NUMBER OF EMPLOYEES
- BUSINESS LOCATION AND ZONING CLASSIFICATION

PAYMENTS CAN TYPICALLY BE MADE BY CHECK, MONEY ORDER, OR CREDIT CARD, DEPENDING ON THE TOWN'S PAYMENT POLICIES. IT IS IMPORTANT TO SUBMIT THE CORRECT FEE AMOUNT TO AVOID PROCESSING DELAYS.

# RENEWAL AND COMPLIANCE

A FORT MILL BUSINESS LICENSE IS NOT A ONE-TIME REQUIREMENT; IT MUST BE RENEWED ANNUALLY OR AS SPECIFIED BY THE TOWN OF FORT MILL. TIMELY RENEWAL ENSURES CONTINUOUS COMPLIANCE WITH LOCAL REGULATIONS AND UNINTERRUPTED BUSINESS OPERATIONS.

## RENEWAL PROCESS

BUSINESS OWNERS WILL RECEIVE RENEWAL NOTICES PRIOR TO THE EXPIRATION DATE. THE RENEWAL PROCESS GENERALLY INVOLVES:

- SUBMITTING AN UPDATED APPLICATION FORM
- PROVIDING ANY CHANGES IN BUSINESS INFORMATION
- PAYING THE RENEWAL FEE BASED ON THE LATEST BUSINESS DATA
- ENSURING ALL APPLICABLE PERMITS AND CERTIFICATES REMAIN VALID

FAILURE TO RENEW A FORT MILL BUSINESS LICENSE ON TIME MAY RESULT IN FINES, PENALTIES, OR SUSPENSION OF BUSINESS OPERATIONS.

## TYPES OF BUSINESSES REQUIRING LICENSES

- PROFESSIONAL SERVICES SUCH AS LEGAL, ACCOUNTING, AND CONSULTING FIRMS
- HOME-BASED BUSINESSES AND CONTRACTORS
- HEALTH AND PERSONAL CARE SERVICES
- MANUFACTURING AND INDUSTRIAL OPERATIONS
- ENTERTAINMENT AND RECREATIONAL FACILITIES

SOME BUSINESSES MAY ALSO REQUIRE ADDITIONAL PERMITS DEPENDING ON THEIR SPECIFIC OPERATIONS, SUCH AS HEALTH INSPECTIONS OR BUILDING PERMITS.

## BENEFITS OF OBTAINING A FORT MILL BUSINESS LICENSE
