- PAY THE APPLICABLE APPLICATION FEE

BONDING AND OATH OF OFFICE

ARIZONA REQUIRES NOTARIES TO OBTAIN A SURETY BOND, TYPICALLY VALUED AT \$5,000, TO PROTECT THE PUBLIC AGAINST ERRORS OR MISCONDUCT. AFTER THE APPLICATION IS APPROVED, THE NOTARY MUST FILE THE OATH OF OFFICE AND BOND WITH THE COUNTY RECORDER'S OFFICE WITHIN 30 DAYS OF COMMISSION ISSUANCE TO ACTIVATE THE NOTARY STATUS OFFICIALLY.

COMMISSION DURATION AND RENEWAL

ARIZONA NOTARY COMMISSIONS ARE VALID FOR FOUR YEARS. RENEWAL REQUIRES SUBMITTING A NEW APPLICATION AND BOND PRIOR TO EXPIRATION. MAINTAINING TRAINING AND STAYING UPDATED WITH ANY CHANGES IN NOTARY LAWS IS ADVISABLE DURING THE COMMISSION PERIOD.

KEY RESPONSIBILITIES AND DUTIES OF NOTARIES

MAINTAINING A NOTARY JOURNAL

ARIZONA LAW ENCOURAGES NOTARIES TO KEEP A DETAILED JOURNAL OF ALL NOTARIZATIONS PERFORMED. THIS RECORD INCLUDES DATES, TYPES OF DOCUMENTS, SIGNER INFORMATION, AND IDENTIFICATION USED. A WELL-MAINTAINED JOURNAL PROTECTS NOTARIES IN CASE OF DISPUTES OR LEGAL INQUIRIES.

ADMINISTERING OATHS AND AFFIRMATIONS

NOTARIES ALSO ADMINISTER OATHS AND AFFIRMATIONS, WHICH INVOLVE LEGALLY BINDING PROMISES MADE BY INDIVIDUALS REGARDING THE TRUTHFULNESS OF STATEMENTS OR DOCUMENTS. PROPER ADMINISTRATION OF THESE ACTS REQUIRES CLEAR UNDERSTANDING OF LEGAL PROTOCOLS.
