### RAGE AGAINST THE MACHINE – POLITICAL ACTIVISM IN MUSIC

## LEGAL AND ETHICAL CONSIDERATIONS SURROUNDING FREEDOM OF SPEECH IN MUSIC

## LEGAL PROTECTIONS AND LIMITATIONS

IN THE UNITED STATES, THE FIRST AMENDMENT PROVIDES STRONG PROTECTIONS FOR FREEDOM OF SPEECH, INCLUDING LYRICS. HOWEVER, THESE RIGHTS ARE NOT ABSOLUTE, AND CERTAIN CONTENT MAY BE SUBJECT TO LEGAL ACTION UNDER SPECIFIC CIRCUMSTANCES.

1. OBSCENITY LAWS RESTRICT EXPLICIT CONTENT THAT LACKS SERIOUS ARTISTIC VALUE.
2. DEFAMATION LAWS PROTECT INDIVIDUALS FROM FALSE AND DAMAGING STATEMENTS.
3. HATE SPEECH REGULATIONS VARY BY JURISDICTION AND CONTEXT.

## FREQUENTLY ASKED QUESTIONS

### WHAT DOES 'FREEDOM OF SPEECH LYRICS' TYPICALLY REFER TO?

### HOW DO ARTISTS USE FREEDOM OF SPEECH IN THEIR LYRICS TO INFLUENCE SOCIETY?

ARTISTS USE THEIR LYRICS TO HIGHLIGHT INJUSTICES, INSPIRE CHANGE, PROVOKE THOUGHT, AND GIVE VOICE TO MARGINALIZED GROUPS, LEVERAGING THEIR PLATFORM TO IMPACT PUBLIC OPINION AND CULTURE.

### WHAT ARE SOME FAMOUS SONGS KNOWN FOR THEIR FREEDOM OF SPEECH LYRICS?

SONGS LIKE BOB DYLAN'S 'THE TIMES THEY ARE A-CHANGIN'', PUBLIC ENEMY'S 'FIGHT THE POWER', AND N.W.A'S 'F\*\*\* THA POLICE' ARE WELL-KNOWN FOR THEIR POWERFUL FREEDOM OF SPEECH LYRICS ADDRESSING SOCIAL AND POLITICAL ISSUES.

### HOW DOES CENSORSHIP AFFECT FREEDOM OF SPEECH IN LYRICS?
