INJURY AND ILLNESS TREATMENT

OCCUPATIONAL MEDICINE PROVIDERS DIAGNOSE AND TREAT A VARIETY OF WORK-RELATED CONDITIONS, INCLUDING MUSCULOSKELETAL INJURIES, RESPIRATORY ILLNESSES, AND SKIN DISORDERS. PROMPT AND APPROPRIATE MEDICAL INTERVENTION HELPS MINIMIZE RECOVERY TIME AND PREVENT COMPLICATIONS.

DRUG AND ALCOHOL TESTING

EMPLOYEE TRAINING PROGRAMS

TRAINING SESSIONS EDUCATE WORKERS ON SAFE PRACTICES, PROPER EQUIPMENT USE, AND HAZARD RECOGNITION. THESE PROGRAMS EMPOWER EMPLOYEES TO ACTIVELY PARTICIPATE IN MAINTAINING A SAFE WORKPLACE.

CASE MANAGEMENT AND REHABILITATION

WHEN INJURIES OCCUR, OCCUPATIONAL MEDICINE SPECIALISTS COORDINATE CARE TO FACILITATE RECOVERY AND RETURN TO WORK. THIS MAY INCLUDE PHYSICAL THERAPY, MODIFIED DUTY ASSIGNMENTS, AND ONGOING MEDICAL MONITORING.
