Women candidates are entitled to the same age relaxations as applicable to their respective categories. There is no separate age relaxation solely based on gender.

Additional Eligibility Conditions

However, candidates from categories other than Indian citizens must produce a certificate of eligibility issued by the Government of India.

Number of Attempts Allowed

The UPSC prescribes a maximum number of attempts for the IAS exam based on the candidate's category:

- General category: 6 attempts.
- OBC category: 9 attempts.
- No limit on attempts for SC/ST candidates up to the age limit.

These restrictions are intended to encourage timely preparation and fair opportunity for all aspirants.

Physical Standards

While there are no strict physical requirements for the IAS exam itself, candidates selected for certain civil services may have to meet specific medical standards during the final stages of recruitment.
