- IMPEACHING FEDERAL OFFICIALS
- RATIFYING TREATIES (SENATE)

THE EXECUTIVE BRANCH

THE EXECUTIVE BRANCH ENFORCES LAWS AND IS HEADED BY THE PRESIDENT OF THE UNITED STATES. THIS BRANCH INCLUDES THE VICE PRESIDENT, THE PRESIDENT'S CABINET, AND VARIOUS FEDERAL AGENCIES AND DEPARTMENTS. THE EXECUTIVE BRANCH IMPLEMENTS AND ADMINISTERS FEDERAL LAWS AND POLICIES, DIRECTS NATIONAL DEFENSE AND FOREIGN AFFAIRS, AND MANAGES DAY-TO-DAY GOVERNANCE.

CORE FUNCTIONS OF THE EXECUTIVE BRANCH INCLUDE:

- ENFORCING LAWS PASSED BY CONGRESS
- SERVING AS COMMANDER-IN-CHIEF OF THE ARMED FORCES
- CONDUCTING DIPLOMACY AND NEGOTIATING TREATIES
- ISSUING EXECUTIVE ORDERS
- APPOINTING FEDERAL OFFICIALS AND JUDGES (WITH SENATE APPROVAL)

THE JUDICIAL BRANCH

THE JUDICIAL BRANCH INTERPRETS LAWS AND ENSURES THEY ARE APPLIED FAIRLY. IT IS MADE UP OF THE FEDERAL COURT SYSTEM, WITH THE SUPREME COURT AS THE HIGHEST AUTHORITY. THIS BRANCH REVIEWS LAWS AND EXECUTIVE ACTIONS TO DETERMINE THEIR CONSTITUTIONALITY AND RESOLVES DISPUTES BETWEEN STATES, INDIVIDUALS, AND GOVERNMENT ENTITIES.

PRINCIPAL ROLES OF THE JUDICIAL BRANCH INCLUDE:

- INTERPRETING AND APPLYING THE CONSTITUTION
- REVIEWING LAWS TO ENSURE THEY COMPLY WITH CONSTITUTIONAL PRINCIPLES
