MARYLAND REAL ESTATE CONTINUING EDUCATION REQUIREMENTS

THE MARYLAND REAL ESTATE COMMISSION MANDATES THAT LICENSED REAL ESTATE PROFESSIONALS COMPLETE CONTINUING EDUCATION COURSES TO RENEW THEIR LICENSES. THESE REQUIREMENTS ARE DESIGNED TO ENSURE THAT AGENTS AND BROKERS MAINTAIN A HIGH LEVEL OF COMPETENCY AND ADHERE TO REGULATORY STANDARDS. MD REAL ESTATE CONTINUING EDUCATION CLASSES TYPICALLY INCLUDE A SET NUMBER OF CREDIT HOURS THAT MUST BE COMPLETED WITHIN EACH LICENSING CYCLE, WHICH USUALLY SPANS TWO YEARS.

CREDIT HOUR REQUIREMENTS

THE REMAINING HOURS CAN BE SELECTED FROM A LIST OF APPROVED ELECTIVE COURSES THAT COVER DIVERSE TOPICS LIKE MARKETING, FINANCE, AND PROPERTY MANAGEMENT.

TIMING AND RENEWAL PROCESS

LICENSEES ARE REQUIRED TO FULFILL THEIR CONTINUING EDUCATION OBLIGATIONS BEFORE THE EXPIRATION OF THEIR LICENSE TO AVOID PENALTIES OR LICENSE SUSPENSION. THE MARYLAND REAL ESTATE COMMISSION SETS SPECIFIC DEADLINES, AND IT IS THE RESPONSIBILITY OF THE LICENSEE TO ENSURE TIMELY COMPLETION. UPON FINISHING THE REQUIRED COURSES, PROOF OF COMPLETION MUST BE SUBMITTED AS PART OF THE LICENSE RENEWAL APPLICATION.
