COMPARISON WITH GENERAL POPULATION

VARIABILITY ACROSS AGENCIES AND REGIONS

FACTORS CONTRIBUTING TO DIVORCE IN LAW ENFORCEMENT

THIS IMBALANCE IS A SIGNIFICANT FACTOR IN POLICE OFFICER DIVORCE STATISTICS, AS CONSISTENT FAMILY ENGAGEMENT IS A KNOWN PROTECTIVE FACTOR AGAINST MARITAL DISSOLUTION.

FINANCIAL PRESSURES

GENDER DIFFERENCES

MALE AND FEMALE POLICE OFFICERS MAY EXPERIENCE MARITAL CHALLENGES DIFFERENTLY. FEMALE OFFICERS OFTEN FACE ADDITIONAL STRESS FROM BALANCING CAREER DEMANDS WITH SOCIETAL EXPECTATIONS AROUND FAMILY ROLES.
