HISTORICAL CONTEXT OF POLITICAL CARTOONS ON LAW ENFORCEMENT

THE IMAGERY SHIFTED TO INCLUDE MORE NUANCED PORTRAYALS OF FORCE, HIGHLIGHTING ABUSES AND THE FINE LINE BETWEEN MAINTAINING ORDER AND VIOLATING RIGHTS.

ROLE DURING MAJOR POLITICAL EVENTS

POLITICAL CARTOONS GAINED PROMINENCE DURING SIGNIFICANT POLITICAL EVENTS SUCH AS THE CIVIL RIGHTS MOVEMENT, PROHIBITION, AND ANTI-WAR PROTESTS. COMMON THEMES IN POLITICAL CARTOONS ABOUT USE OF FORCE
