THE WEDC WORKS CLOSELY WITH LOCAL GOVERNMENT ENTITIES, COMMUNITY ORGANIZATIONS, AND EDUCATIONAL INSTITUTIONS TO CREATE A BUSINESS-FRIENDLY ENVIRONMENT THAT SUPPORTS LONG-TERM PROSPERITY. ITS STRATEGIC INITIATIVES ALIGN WITH REGIONAL AND STATE ECONOMIC DEVELOPMENT PLANS, REINFORCING WILSON COUNTY'S POSITION AS A COMPETITIVE LOCATION FOR INVESTMENT AND GROWTH.

ORGANIZATIONAL STRUCTURE
