ELIGIBILITY AND PRE-LICENSING REQUIREMENTS

BEFORE SITTING FOR THE WISCONSIN REAL ESTATE LICENSE EXAM, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY THE WISCONSIN DEPARTMENT OF SAFETY AND PROFESSIONAL SERVICES (DSPS). THESE REQUIREMENTS ENSURE THAT APPLICANTS POSSESS THE FOUNDATIONAL KNOWLEDGE AND QUALIFICATIONS NECESSARY FOR A CAREER IN REAL ESTATE.

BASIC ELIGIBILITY CRITERIA

SCHEDULING THE EXAM

ONCE THE APPLICATION IS APPROVED, CANDIDATES RECEIVE AUTHORIZATION TO SCHEDULE THEIR WISCONSIN REAL ESTATE LICENSE EXAM. EXAMS ARE ADMINISTERED BY THIRD-PARTY TESTING CENTERS AT VARIOUS LOCATIONS STATEWIDE, OFFERING FLEXIBILITY IN SELECTING CONVENIENT DATES AND TIMES.
