ORIGINS AND FOUNDING OF WOODMEN OF THE WORLD

THE WOODMEN OF THE WORLD HISTORY BEGINS IN THE YEAR 1890 WITH THE ESTABLISHMENT OF THE WOODMEN OF THE WORLD LIFE INSURANCE SOCIETY. IT WAS FOUNDED BY JOSEPH CULLEN ROOT IN OMAHA, NEBRASKA, DURING A PERIOD WHEN FRATERNAL BENEFIT SOCIETIES WERE BECOMING POPULAR IN THE UNITED STATES. ROOT ENVISIONED AN ORGANIZATION THAT COMBINED LIFE INSURANCE BENEFITS WITH FRATERNAL FELLOWSHIP, PROVIDING FINANCIAL SECURITY AND SOCIAL SUPPORT TO ITS MEMBERS. THE SOCIETY DREW INSPIRATION FROM EARLIER WOODMEN ORGANIZATIONS, SUCH AS THE MODERN WOODMEN OF AMERICA, BUT SOUGHT TO CREATE A UNIQUE IDENTITY WITH DISTINCTIVE RITUALS AND BENEFITS.

JOSEPH CULLEN ROOT AND EARLY VISION

JOSEPH CULLEN ROOT, A PROMINENT ADVOCATE FOR FRATERNAL INSURANCE, PLAYED A CRUCIAL ROLE IN SHAPING THE WOODMEN OF THE WORLD. HIS VISION WAS TO DEVELOP A SOCIETY THAT OFFERED AFFORDABLE LIFE INSURANCE TO WORKING-CLASS AMERICANS WHILE FOSTERING A SENSE OF BROTHERHOOD AND COMMUNITY RESPONSIBILITY. UNDER HIS LEADERSHIP, THE SOCIETY QUICKLY GAINED MEMBERS AND ESTABLISHED LOCAL CAMPS ACROSS THE MIDWEST.

INITIAL RITUALS AND SYMBOLISM
